IMPORTANT SAFETY RECALL

This notice applies to your vehicle (VIN: ZFXXXXXXXXXXXXXXXXXX).

Dear [Mr. John Doe],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ferrari has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2022 - 2023 Ferrari 296 vehicles. The vehicles involved are equipped with a fuel tank connecting pipe that may experience some corrosion due to the unintended contact between the pipe and the high-voltage battery protection cover. This could potentially allow for the formation of a hole in the pipe that could permit fuel leakage. Fuel leakage in the presence of an external ignition source may increase the risk of fire. We want to assure you that your safety is our priority, and we are committed to correcting this condition in your vehicle if it exists.

Our records show that you are the owner of a vehicle affected by this recall.

IMPORTANT

Ferrari will repair your vehicle free of charge. The repair consists of replacing the vehicle's current fuel tank connecting pipe with a new connecting pipe reinforced with an anti-corrosive protective sleeve.

The replacement part is not yet available; we will contact you again when the replacement part is in dealer stock. The time needed for the repair is estimated to be approximately 2 hours. **In the meantime, you should not use your vehicle.**

If you have previously paid for repair to your vehicle for this specific condition prior to receiving this letter, send your original receipts and/or other adequate proof of payment to the following address for reimbursement: Ferrari North America, Inc., 250 Sylvan Ave., Englewood Cliffs, NJ 07632 Attention: Warranty Department. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days.

For vehicles registered in California: The California Department of Motor Vehicles, in conjunction with California Air Resources Board, requires the completion of emission recall repairs prior to vehicle registration renewal, per the Registration Renewal/Recall Tie-in Program. Your authorized Ferrari dealer will provide you with a Proof of Correction Certificate after the recall repair has been performed.
