

IMPORTANT SAFETY RECALL

This notice applies to your vehicle, 7SMF5EJ29SB000413.

Dear Matthew Ford,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Fruehauf Inc., based on information provided by SAF-HOLLAND, has decided that a defect, which relates to motor vehicle safety, exists in certain 2025 Fruehauf composite Dry Van trailers.

WHY DOES MY VEHICLE NEED REPAIRS?

Trailers equipped with Tire Pilot Plus – Electronic Regulator Control Unit Assembly tire pressure regulation system (TPRS) may experience unintended loss of pressure of all 8 tires while traveling at speeds higher than 45 mph. This can cause reduced vehicle control and/or stability, increasing the risk of a crash. Risk of tire tread separation and debris on the road.

WHAT WILL YOUR DEALER DO?

SAF HOLLAND is still finalizing a remedy. In the interim your dealer will disable the TPP system, free of charge. The interim repair should take approximately .5 hours to complete. However, due to scheduling, your dealer may require your vehicle for longer. Your dealer should be able to provide a more accurate repair estimate. You will receive a second notice once the final remedy becomes available.

WHAT SHOULD YOU DO?

Many of the affected trailers have already had the disabling service bulletin performed. You can verify this with the included service bulletin. If it has not already been performed, please contact SAF HOLLAND for a local authorized dealer and schedule an appointment for your free service bulletin as soon as possible. To find your nearest dealer, visit safholland.com or call their warranty line at 800-767-6967. You will receive a second notice when a permanent remedy becomes available.
