What is the Concern?



On certain Sprinter vehicles, the topcoat paint formula may cause the fixed windows and interior lashing rails to be insufficiently bonded to the vehicle. As a result, an insufficiently bonded window can detach during a crash, and objects secured to an insufficiently bonded interior lashing rail can detach, increasing the risk of injury

Unfortunately, the parts to remedy this are not yet available.

We are working to obtain the necessary parts to correct this condition as quickly as possible. As parts become available, we will send you another letter asking you to take your vehicle to an authorized Freightliner Sprinter dealer to have the recall completed free of charge.

A vehicle identification number (VIN)-based recall lookup tool, on our website offers a search function that will indicate whether a vehicle has been subject to a safety recall, and whether that vehicle has had the free remedy performed.
