## IMPORTANT SAFETY RECALL – FREE INTERIM REPAIR

### HIGH-VOLTAGE (HV) BATTERY MODULE REPAIR NEEDED

This notice applies to your vehicle: <VIN>, <MODELYEAR> <BRAND> <MODEL>

<p><b>ABOUT THIS RECALL:</b> NHTSA: 23V867 / Audi Recall 93V2</p>	<p>A potentially critical self-discharge condition exists in certain high-voltage (HV) battery modules that, in some instances, may lead to thermal overload, possibly resulting in smoke or a fire. A high-voltage battery overheating increases the risk of a fire.</p>
<p><b>WHY WE SENT THIS NOTICE:</b></p>	<p>At the time this notice was mailed, our records show that online data collection was activated for your vehicle, and Audi’s Online Field Monitoring program records show that one or more of the HV battery modules in your vehicle requires replacement.</p> <p><i>Audi will continue to retrieve and analyze data from the HV battery modules in your vehicle, as long as your vehicle is driven and Privacy Mode is not engaged.</i></p>
<p><b>WHAT YOU SHOULD DO:</b></p>	<p>Please contact your authorized Audi dealer without delay to schedule this <u>FREE</u> repair as soon as possible. The necessary HV battery module replacement(s) will be done for you <u>FREE</u> of charge. This can take up to three days to complete, depending on the number of modules requiring replacement.</p>
<p><b>PRECAUTIONS TO TAKE:</b></p>	<p><b>Audi recommends you set the maximum battery charge to 80%. This is an important measure to help protect the high-voltage battery modules in your vehicle until your dealer has repaired the faulty module(s).</b></p> <p>Once the faulty module(s) have been repaired by your authorized Audi dealer, you may resume charging normally.</p>
