Descriptive Information : During a routine audit of the One4Life® Slim ClickTight® All-in-One car seat ("One4Life Slim"), it was discovered that the label and user guide were incorrect and listed the maximum weight for rear-facing installation at 40 lbs. when the correct maximum weight is instead 35 lbs. for rear-facing installation. Production records were used to identify the population of affected car seats and the range of manufacture dates. The first date of manufacture for One4Life was July 10, 2024.

Description of Noncompliance :

Description of the Noncompliance : The One4Life Slim labels and user guide incorrectly listed 40 lbs. as the maximum rear-facing lower anchor weight. Instead, the maximum rear-facing lower anchor weight should be 35 lbs. in accordance with S5.5.2(l)(3)(i)(C) of FMVSS No. 213.

Description of the Safety Risk : Britax has determined that the maximum rear-facing lower anchor weight calculation listed on the One4Life Slim label and user guide does not meet the

Description of the Cause : requirement of S5.5.2(l)(3)(i)(C) of FMVSS No. 213. If the One4Life Slim is installed rear-facing using lower connectors with a child weighing over 35 lbs., it may not adequately protect the child from injury in the event of a crash.

Chronology :

On November 13, 2024, Britax conducted a routine audit of the One4Life Slim car seat and it was discovered that the related label and user guide stated a 40lb maximum weight capacity for rear-facing installation with lower anchors. The product was immediately placed into quarantine and a stop shipment was issued on any outbound orders while investigation into this maximum weight capacity was evaluated. It was later determined that this 40lb weight capacity was incorrect in accordance with under the FMVSS 213 Table for S5.5.2(l)(3)(i)(C) and instead needs to be stated as 35lbs.

Description of Remedy :

Description of Remedy Program :	<p>Britax will provide all owners of the One4Life Slim car seat models E1D197A, E1D197B, E1D197F and E1d197G a remedy kit, free of charge. The remedy kit will include a label to be inserted to correct the user guide, replacement labels to be placed over the original on-product labels, , and an instruction sheet for application of the remedy labels.</p> <ol style="list-style-type: none">1. Britax will send remedy kits to registered One4Life Slim owners via U.S. mail without any action of the owner.2. Britax will send remedy kits to One4Life Slim owners that contact Britax via email, telephone, or web contact.3. Britax will notify dealers and retailers with information that One4Life Slim owners need in order to receive remedy kits.
How Remedy Component Differs from Recalled Component :	<p>The original One4Life Slim labels and user guides list a maximum rear-facing lower anchor weight limit of 40 lbs. The remedy label and user guide label state a maximum rear-facing lower anchor weight limit of 35 lbs. and emphasizes to the user that they should disregard any reference to 40 lbs. as the maximum weight for rear-facing installation with lower anchors.</p>
Identify How/When Recall Condition was Corrected in Production :	<p>All applicable labels and user guides on One4Life Slim child restraint systems manufactured after November 15, 2024, will include the correct rear-facing 35 lb. weight capacity for lower anchor installation. The newly manufactured products will have different model numbers than the recalled units. In addition, units built after July 15, 2024 but not yet distributed to retailers will be remedied before shipment, and a new model number will be issued and assigned to these corrected products.</p>
