Descriptive Information: This recall includes certain front-driver airbag modules produced for use as

service replacements in 2011 – 2012 model year Chevrolet Silverado 1500, Suburban, and Tahoe vehicles. Modules containing inflators from the suspect manufacturing lot were identified using part traceability data. Warranty data and vehicle service records were used to identify six VINs that may have received

a module containing an inflator from the suspect manufacturing lot.

Front-driver airbag modules not containing inflators from the suspect

manufacturing lot are not part of this recall.

## **Description of Defect:**

Description of the Defect: General Motors has decided that a defect which relates to motor vehicle safety may exist in certain front-driver airbag modules produced for use as service replacements for 2011 - 2012 model year Chevrolet Silverado 1500, Suburban, and Tahoe vehicles. These front-driver airbag modules, which may have been installed as service/replacement parts and not original equipment, may contain an inflator that was built with a supplier-manufacturing defect that may prevent the proper deployment of the second-stage of the airbag in certain high-speed crashes.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: If the vehicle is involved in a high-speed crash that triggers the second-stage

deployment of the driver frontal airbag, the inflator may not fill the airbag as completely and as quickly as designed, which could lead to an increased risk

of injury to the driver.

Description of the Cause: GM is continuing its investigation into the cause of this condition.

#### **Chronology:**

GM opened a product investigation on December 1, 2023, following notification of a driver airbag inflator that failed to properly deploy the second-stage of the airbag during high output laboratory testing. This inflator was originally manufactured for use in driver airbag modules intended for service use on installation in GM's GMT900 platform vehicles.

On January 2, 2024, GM was notified that two additional inflators from the same manufacturing lot exhibited similar anomalies during continued testing. GM's investigation identified five inflators that may have been installed as a service part in six vehicles.

On February 1, 2024, GM's Safety Field Action Decision Authority (SFADA) decided to conduct an equipment safety recall of front-driver airbag modules containing an inflator from the suspect manufacturing lot. GM is

not aware of any field incidents associated with this defect.

## **Description of Remedy:**

Description of Remedy Program: Dealers will replace the driver air bag module. Pursuant to 577.11,

General Motors does not plan to provide notice about reimbursement to owners because owners would not have been aware of the issue prior to

this recall.

How Remedy Component Differs The remedy component does not contain an inflator that was
