Description of the Defect: The LED backlight printed circuit boards (PCB) are not fully coated. The lack of

conformal coating in the connection passages between the layers of the PCB can allow liquid from the cooktop surface to accumulate which could result in a

short circuit resulting in the failure of the PCB.
