Following a higher than expected rate of warranty claims in 2024, Hiniker investigated the matter and, on April 29, 2024, received an electrical engineering opinion that the specified diode and the specified wire gauge were insufficient to handle the amperage that could be experienced under certain operating conditions or with certain installations. This could result in failures owing to the overheating's affecting the plow lights and the vehicle lights.

redesigned motherboard. When the newly designed component has passed testing, placement components will be supplied to the field along
