**Descriptive Information :** Approximately 5 dealer accessory side bag holders may have been delivered by the supplier with bolts for mounting that do not correspond to specification.

**Basis for recall population determination:** Accessory sales records and parts logistics information were reviewed to determine the number of potentially affected side bag holders that may have been delivered to dealers or retailed to customers.

**Recall component difference to non-recall component:** The dealer accessory side bag holder requires longer bolts for mounting.

## Description of Defect :

**Description of the Defect :** This safety recall involves the dealer accessory side bag holder. The mounting kit for the holder contains bolts that are shorter than specified. Therefore, the holder cannot be securely fixed to the motorcycle's rear frame. During riding, the holder (possibly with side bag attached) could detach from the motorcycle.

**Description of the Safety Risk :** If the holder detached while riding, the holder, and possibly an attached side bag, could become a hazard for road users and could increase the risk of a

crash.

## Chronology :

On May 21, 2024, a non-US dealer reported that the bolts contained in the accessory side bag holder kit were too short for proper mounting on the rear frame.

An engineering review was conducted and involved a comparison of drawing and CAD data which resulted in a discrepancy of bolt lengths. It was found that the CAD data had not been transferred correctly into the (build-to-print) drawing which was provided to the supplier.

On May 28, 2024, BMW decided to conduct a voluntary safety recall for the accessory side bag holder.

BMW has not received any customer complaints, field reports, or warranty claims in the US market that relate to this issue.

BMW has not received any reports, nor is BMW otherwise aware, of any accidents or injuries that relate to this issue.

**Description of Remedy :**

Description of Remedy Program : The bolts contained in the mounting kit will be replaced with bolts of the correct length.

Owner notification is not necessary as potentially affected side bag holders have not been retailed.
