Chronology :

When first cracks were discovered, we made some calls to get some local trailers back to evaluate. We decided to do a complete recall when there was more than one trailer with the defect.

January 4, 2024 - Belmont was contacted by a trailer owner that they had had an issue while on the road. Trailer was pulled over to the side of the road and raised with a jack. Wheel was able to be pulled off by hand. Owner managed to safely get the empty trailer home.

January 10, 2024 - Belmont Trailers picked up the trailer and evaluated the issue. Trailer showed the weld had failed on the spindle. While this trailer was in the shop, Belmont reached out to local owners to request that we could evaluate their trailers to see if this was an isolated incident.

January 15, 2024 - A bulletin was sent out to dealers requesting owner information and visual inspections on trailers on their lot.

January 25, 2024 - Belmont Trailers met with insurance rep and a rep from NATM on recall standards.

February 9, 2024 - Trailer owner in Oklahoma experienced a weld failure. Owner safely returned trailer home.

February 13, 2024 - Belmont filed recall report with NHTSA.

No injuries or deaths have been reported.

Description of Remedy :

Description of Remedy Program :	Belmont will assist in locating a reputable place to have the spindles grinded out and re-welded. This will be at no charge to the customer. Repair instructions as well as a brake flanges and attaching hardware will be supplied to the repair location. Bills submitted to Belmont will be paid upon receipt. Estimated repair time is 4 hours. Reimbursement will be provided if the recall was complete already. If vehicles are still under warranty, reimbursement will not be needed.
How Remedy Component Differs from Recalled Component :	An extra weld with be applied on either side to ensure a strong bond.
	Upon discovery of the first spindle weld failure, the welding process was evaluated, and extra steps are now in place to ensure a strong weld.
