#### **Chronology** :

• On January 12, 2024, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization opened an investigation into some 2023-2024 MY Jeep Grand Cherokee vehicles potentially built with a suspect steering knuckle with incomplete finish machining.

• During January 2024, FCA US TSRC conducted an analysis of loss of steering patterns and vehicle history and determined that the affected vehicles were equipped with suspect steering knuckles.

• As of January 31, 2024, FCA US is not aware of any customer assistance records, warranty claims or field reports potentially related to this issue for all markets.

• As of January 31, 2024, FCA US is not aware of any accidents or injuries potentially related to this issue for all markets.

• On February 15, 2024, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

	Description of Remedy Program :	FCA US will conduct a voluntary safety recall to replace the steering knuckle.
		FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
		Remedy will be to replace the improperly machined steering knuckle with a properly machined steering knuckle.
