On February 9, 2024, the manufacturing plant received a single complaint from a dealer, in which the ceiling started discoloring above the Cadet Heater.

On February 16, 2024, the manufacturing plant met with the supplier of the Cadet Heater and had a review of the installation. The manufacturers' installation instructions appear to indicate how much clearance above the Cadet Heater is required. The installation instructions appear to only provide the minimum clearances required from the bottom, left, and right of the Cadet Heater. After looking at the physical component, the manufacturing plant located a sticker on the back of the Cadet Heater which dictates the required vertical clearance above the heater. The same day, the manufacturing plant notified Forest River's Office of Corporate
