**Description of the Noncompliance :** In affected vehicles, the front seat belts may contain a partially crimped lap pre-tensioner due to a supplier error that has since been corrected.

FMVSS 1 : NR

**Description of the Safety Risk :** A partially crimped pre-tensioner may not restrain the occupant as intended and may not meet the requirements of S5.5 of Federal Motor Vehicle Safety Standard (FMVSS) No. 208, Occupant Crash Protection; FMVSS No. 209, Seat Belt Assemblies; and FMVSS No. 210, Seat Belt Assembly Anchorages, increasing the risk of injury in a crash.
