## Description of Defect :

**Description of the Defect :** The front tire may not conform to FMVSS119 due to an improper manufacturing process.

**FMVSS 1 :** 119 - New pneumatic tires- other than passenger cars

**FMVSS 2 :** NR

**Description of the Safety Risk :** There is a risk that the front tire may blister on the inner surface and thereby fail to conform to FMVSS119. This could increase the risk of a crash.

**Description of the Cause :** Error during installation of the sidewall rubber of tire.

## Chronology :

- End of January 2024: Kawasaki Motors, Ltd (KML) was notified by its supplier (Sumitomo Rubber Industries, Ltd.) of an irregular test result in tire certification testing. KML requested that the supplier investigate this issue.
- April 2024: The supplier reported that a certain range of tires may not conform to FMVSS119.
- April 12th, 2024: KML decided to initiate a recall campaign.

## Description of Remedy :

Description of Remedy Program : Front tires will be replaced on all units. The plan of reimbursement has been described on the owner's letter as follows: If you have experienced the failure described above prior to receiving this letter and have paid to have it corrected, you may be eligible for full or partial reimbursement for your documented cost of repair(s). How Remedy Component Differs from Recalled Component : Tires with lot numbers in the affected range will be replaced. Tires with lot numbers not in the affected range are not affected by the recall.

Identify How/When Recall Condition was Corrected in Production : From January 27, 2024, all tires supplied to KML conform to FMVSS.
