Description of the Defect :	Suburban Manufacturing has advised on recall 24E-028 The LED backlight printed circuit boards (PCB) are not fully coated. The lack of conformal coating in the connection passages between the layers of the PCB can allow liquid from the cooktop surface to accumulate which could result in a short circuit resulting in the failure of the PCB.

Description of the Safety Risk :	If the PCB fails, it can become overheated, and the polyethylene cover of the lights can melt and possibly ignite causing a fire.

ATC determined the recall population and confirmed receipt of the impacted product 5/15/2024 and proceeded to file the claim

Description of Remedy Program :	There are 2 remedies for this issue. The LED backlights can be removed from the range, or the circuit powering the LED backlights can be cut and properly terminated. ATC will supply replacement materials if needed as they will be provided by Suburban under the recall. ATC will work with Suburban to supply the parts kits to service facilities making the repair. If a customer or dealer has incurred costs for the range that would have been covered with this repair, those costs will be reimbursed.
