This recall involves Z71 and Trail Boss trimline vehicles that were ordered with 20" tires with black wheels (LPO SNX). Vehicles with other tire/wheel configurations are not affected by this recall

Description of the Noncompliance : General Motors has decided that certain 2024 model year Chevrolet Colorado vehicles fail to conform to S4.3.3 of Federal Motor Vehicle Safety Standard (FMVSS) No. 110 and S4.2(a) of FMVSS No. 138. Incorrect tires may have been installed on these vehicles that do not match the vehicle's tire label. In addition, the tire pressure monitoring system (TPMS) does not provide accurate information for the incorrect tires.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : 138 - Tire pressure monitoring systems

Description of the Safety Risk : If the tire label does not accurately reflect the installed tires, owners may choose the incorrect tire size when replacing tires. If the TPMS system is not set for the tires installed on the vehicle, drivers might not get a timely warning if a tire's pressure drops below more than 25% of the recommended cold inflation pressure.

**Description of the Cause :** The accessory distributor and installer (ADI) was not provided adequate information to supply dealers with the correct tire and wheel combination for vehicles that were ordered with LPO SNX. Tires provided for Z71 and Trail Boss trim lines may have inadvertently been switched.

## Chronology :

A GM engineer submitted this issue to GM's Speak Up For Safety (SUFS) program on March 15, 2024, following notification from GM's ADI (accessory distributor and installer) that some 20" black wheel packages (LPO SNX) provided to dealers for Colorado Z71 and Trail Boss trim lines may have included incorrect tires. Tires for the two involved trim lines may have been switched. GM opened a product investigation on March 22, 2024. GM's investigation identified 56 vehicles that may have received incorrect tires.

On May 16, 2024, GM's Safety Field Action Decision Authority (SFADA) decided to conduct a noncompliance recall. GM is not aware of any field incidents associated with this defect.

## Description of Remedy :

Description of Remedy Program : Dealers will inspect tires and replace if necessary. With the correct tires installed, the vehicle's tire label and the TPMS will reflect accurate information to the customer.  
Pursuant to 49 C.F.R. § 573.13(d)(1), all covered vehicles are under warranty, so reimbursement is not offered.

How Remedy Component Differs from Recalled Component : Replacement tires are correct for each trim line.

Identify How/When Recall Condition was Corrected in Production : Correct tire information was provided to the ADI on March 11, 2024.
