Description of the Defect: The LED backlight printed circuit boards (PCB) are not fully coated. The lack of

conformal coating in the connection passages between the layers of the PCB can allow liquid from the cooktop surface to accumulate which could result in a

short circuit resulting in the failure of the PCB

Description of the Safety Risk: If the PCB fails, it can be come overheated and the polyethylene cover of the

lights can melt and possibly ignite causing a fire.

Description of the Cause: The PCBs did not have the correct amount of conformal coating to properly seal

the circuit board from contamination.
