Descriptive Information : Some 2024 MY Jeep Wrangler vehicles equipped with the trailer tow option ("TTO"), may have been built with an incorrect Power Distribution Center ("PDC") that prevents the trailer lighting from functioning properly.

The suspect period began on January 4, 2024, when the first suspect vehicle was produced, and ended on January 18, 2024, when last suspect vehicle was produced. Engineering change and vehicle production records were used to determine the suspect period.

Similar vehicles not included in this recall were built before or after the suspect period or do not have the TTO.

Description of the Noncompliance : Federal Motor Vehicle Safety Standard ("FMVSS") Technical Standard Document 108 Lamps, Reflective Devices and Associated Equipment TABLE I-b states that trailer turn signal lamps, tail lamps, stop lamps, side marker lamps, license plate lamps, intermediate side marker lamps, clearance lamps and identification lamps shall function during operation. Vehicles with a suspect PDC may prevent the trailer lighting from functioning properly.

FMVSS 1 : 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2 : NR

Description of the Safety Risk : Trailers with inoperative trailer lighting may result in an approaching vehicle being unaware of the location or change of direction or speed of the vehicle and trailer, which can cause a vehicle crash without prior warning.

Chronology :

- On January 22, 2024, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization was notified of a potential issue related to the PDC on some 2024 MY Jeep Wrangler vehicles.
- From January 2024, through May 2024, FCA US TSRC met with FCA US engineering and manufacturing to review the issue, understand the failure mode, and to determine the suspect population.
- On May 1, 2024, the FCA US TSRC organization recognized that a vehicle build issue existed on certain vehicles related to the incorrect PDC which can lead to inoperative turn signals and stop lamps, potentially resulting in a noncompliance with FMVSS No. 108.
- On May 31, 2024, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

Description of Remedy :

Description of Remedy Program : FCA US will conduct a voluntary safety recall on all affected vehicles to replace the PDC.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.

How Remedy Component Differs from Recalled Component : The remedy is to replace the PDC with the correct PDC.
