6/11/2024 - While reviewing the operation of the griddle option it was discovered that the emergency exit window was partially blocked. A safety committee meeting was conducted the same day, and all agreed to issue a recall. No warranty claims or customer complaints have been received.

Description of Remedy :

Description of Remedy Program : Installation of an emergency exit window on the other side of the motorhome will be installed at no cost to the owner. Any reimbursement will follow the general reimbursement plan that is on file with NHTSA.

How Remedy Component Differs from Recalled Component : The remedy is an additional emergency exit window installed on the opposite side of the motorhome.

Identify How/When Recall Condition was Corrected in Production : Engineering made the change online with production staff on 6/11/2024 the same day it was discovered.
