Description of the Defect: Vehicles may have been manufactured with a door operator rotary plate that

may disconnect from the door operator due to a welding failure.

Description of the Safety Risk: In the event of a rotary plate weld failure, the larger panel of the front door

will no longer be linked to the door operator, which could lead to a door opening while the vehicle is in motion. A passenger door that opens unexpectedly may increase the risk of passenger injury or death.

Chronology:

July 05, 2023: Nova Bus was informed of issues with doors not opening or closing when activated by the driver while the vehicle is stationary.

August 21, 2023: Nova Bus started an internal Investigation to identify other cases of similar door malfunctions.

February 15, 2024: The issue was raised to the safety forum as a potential risk for evaluation.

February 23, 2024: Nova Bus and the supplier launched a part recovery on buses in service that did not report the issue and start a comparative analysis of components.

May 31, 2024: Nova Bus was informed of first case of door opening while bus is in motion.

June 7, 2024: Product Safety Evaluation Committee evaluates and raises to Product Safety Committee.

June 12, 2024: Product Safety Committee determination of product defect. Product Safety Committee also determined that an advance owner's notification should be sent.

June 17, 2024: Nova Bus files 573 with NHTSA that a voluntary recall will be released to address the safety-related defect.

There has been no accidents or injuries related to this defect. There were no warranty claims related to this defect.

Description of Remedy:

Description of Remedy Program: Owners will be notified immediately of the issue and potential safety risk

in order to instruct the drivers not to operate the vehicles with passengers in front of the standee line. Details of the service remedy are not defined at the moment but will be provided once available. Vehicles will be recalled once the remedy is identified. All costs associated with this corrective measure will be covered by Nova Bus. Pre-notification remedies will be addressed using the Nova Bus general reimbursement plan on file

with NHTSA.
