## **Description of Noncompliance:**

Description of the Southeast Toyota Distributors, LLC (SET) is recalling certain 2021-2024 model

Noncompliance: year Highlander L, LE and XLE vehicles with SET installed 20-inch accessory

tires. The installed tires have an insufficient load rating for the vehicle's Gross Axle Weight Rating (GAWR). As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 110, "Tire

Selection and Rims," S4.2.2.2.

#### **Chronology:**

SET received a Field Technical Report in mid-May of 2024 indicating that the tires installed on a 2022 Toyota Highlander had an incorrect load rating. SET investigated and determined that the wrong tire was installed on the affected vehicles. On June 12, 2024, SET decided to conduct a recall to address this issue on vehicles in the field. SET is not aware of any crashes or overloading events potentially related to this issue.

## **Description of Remedy:**

Description of Remedy Program: Tires on affected vehicles will be inspected and replaced free of charge. If

necessary, the tire information placard also will be replaced free of charge. The Owner Notification Letter will include a contact number should an

owner qualify for a pre-recall remedy reimbursement

How Remedy Component Differs The replacement tires will have a load rating that is compliant with FMVSS

from Recalled Component: 110

Identify How/When Recall Condition Upon receiving a field inquiry regarding the load rating of the upgraded was Corrected in Production: accessory tires installed on a Highlander vehicle, SET promptly placed a quality hold on the Highlander 20-inch tire upgrade installation and any in-process vehicles at the vehicle processing facility. SET will replace the tires on the vehicles currently on hold with tires that meet the load rating required by FMVSS 110
