On May 20, 2024, the manufacturing plant received a customer complaint of the ladder block in which detached from the vehicle. The manufacturing plant began review of the ladder block placement on all submodels of the Cross Trail Class C Motorhome.

On June 16, 2024, the manufacturing plant notified Forest River's Office of Corporate Compliance ("OCC") of the concern.

On June 21, 2024, the manufacturing plant and OCC met to review the research the plant conducted from May 21, 2024 through June 16, 2024.

On June 28, 2024, Forest Rivers Corporate Recall Committee voted to recall.

Description of Remedy:

Description of Remedy Program: Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. The remedy will include an inspection for the Lippert Ladder Receiver. If found on the vehicle, it will be removed, bodywork will be performed to cover the original holes and other ladder options will be provided to the Dealer/Consumer.
