The suspect period began on March 7, 2024, when the first vehicle was built with the incorrect tail lamps, and ended on May 13, 2024, when vehicles were no longer shipped with incorrect tail lamps. Engineering release and vehicle production records

were used to determine the suspect period.

Similar vehicles not included in this recall were built before or after the suspect period or were repaired before being released from vehicle plant control.

Chronology:

On May 21, 2024, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization was notified of a potential issue related to some 2024 MY Jeep Wrangler vehicles built with incorrect tail lamps.

From May 2024, through July 2024, FCA US TSRC conducted an analysis of the vehicle build history and determined that the affected vehicles may have been built with incorrect tail lamps.

On July 17, 2024, the FCA US TSRC organization recognized a vehicle build issue existed on certain vehicles that can lead to the incorrect tail lamps to be installed, potentially resulting in a noncompliance with FMVSS No. 108.

On August 01, 2024, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

Description of Remedy:

Description of Remedy Program: FCA US will conduct a voluntary safety recall to replace the tail lamps.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the

expense.

How Remedy Component Differs This recall is not related to a part defect but rather an engineering release from Recalled Component: issue that resulted in a tail lamp / spare tire combination that does not meet FMVSS requirements. Remedy parts are tail lamps which have an

integrated spacer bezel.
