## **Chronology:**

On September 12, 2024, as part of an internal compliance audit involving a MY 2024 Tesla Cybertruck, Tesla identified a potential FMVSS 111, S6.2.3 noncompliance.

From September 13, 2024, to September 19, 2024, Tesla investigated the condition, performed tests to characterize and recreate it, and began scoping the vehicles that potentially could be impacted by it.

On September 19, 2024, having completed its assessment, Tesla determined that a noncompliance exists and made a voluntary recall determination.

As of September 25, 2024, Tesla identified 45 warranty claims and four field reports that may be related to the condition. Tesla is not aware of any collisions, fatalities or injuries that may be related to the condition.

#### **Description of Remedy:**

Description of Remedy Program: Beginning on or shortly after September 19, 2024, at no cost to customers,

affected vehicles received an over-the-air (OTA) software remedy that ensures the back-up camera display complies with the two-second response time, as per FMVSS 111, S6.2.3. No further action is necessary from owners of affected vehicles that are equipped with software release

2024.32.5.2 or a later release.
