Defect / Noncompliance Description

Description of the defect or noncompliance:

Certain Winnebago vehicles are equipped with front turn signal lamps that do not meet the luminous lens area requirements. As such these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard FMVSS No. 108, "Lamps, Reflective Devices, and Associated Equipment."

FMVSS1: 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS2:

Description of the safety risk, including crash, fire, death, injury:

The failure to be equipped with turn signals compliant with FMVSS No. 108, "Lamps, Reflective Devices, and Associated Equipment", reduces other road users' visibility of the signal lamps. Reduced visibility may lead roadway users to misunderstand the intent to turn or make lane changes which increases the risk of a crash.

Chronology

In late July of 2022, while in discussions with a lamp manufacturer on a new turn signal, the lamp manufacturer informed Winnebago there was a concern that the current lamp did not meet FMVSS 108 requirements for effective projected luminous lens area for Class A motorhomes. An investigation and subsequent assessment of the subject turn signal and relevant standards confirmed the concern. The Winnebago Product Safety Committee met to review the issue in early November and determined that the turn signals were noncompliant, however no safety risk was identified. Therefore, it was decided to file the required 573 and submit a petition for inconsequential noncompliance. On September 24, 2024 NHTSA completed their review and denied the petition for inconsequential non-compliance. Winnebago acknowledged the denial and filed this notice of defect in response. There are no known incidents associated with this noncompliance. Final remedy is pending parts availability from the supplier.

Remedy A is being released on January 9, 2026. Remedy B is currently waiting on parts and still in determination for a release date.
