## Description of Defect :

Description of the Defect : According to GE campaign 24E071: "GE Appliances has decided that a defect which relates to motor vehicle safety exists in the ICM Controls ICM870-16A-BH5400 soft start units manufactured prior to the spring of 2024. The soft start modules may contain an unknown design and/or manufacturing defect that increases the risk of thermal events."

**Description of the Safety Risk :** According to GE campaign 24E071: "In the event that an ICM870-16A-BH5400 unit undergoes and/or initiates a thermal event, the unit may emit smoke containing the byproducts of plastic or other component material combustion and/or experience a thermal breach the soft start's enclosure, leading to the destruction of the soft start and/or localized thermal damage to the area of the air conditioning where the soft start is located. Although unconfirmed at this time, the thermal event may, in very limited instances, have the potential to spread beyond the recreational vehicle's air conditioning into the recreational vehicle's construction."

**Description of the Cause :** According to GE campaign 24E071: "GE is still investigating the root cause".

**Identification of Any Warning that can Occur :** According to GE campaign 24E071: "Based on currently available information, it appears that potentially affected recreational vehicle air conditioning units may cycle excessively or cease cooling if the ICM870-16A-BH5400 soft start fails, resulting in the inoperability of the installed air conditioning's compressor. Units may emit smoke and/or a burning odor, either into the RV cabin or through the external (roof mounted) housing of the unit."

## Chronology :

On October 9, 2024, Forest River's Office of Corporate Compliance ("OCC") was notified by its supplier, GE of their equipment recall 24E071. OCC opened a research item to see if and/or where the recalled components

had been used.

On October 10, 2024, Forest Rivers Corporate Recall Committee was notified of the GE equipment campaign.

On November 11, 2024, Forest River amended the recall to reflect there was not a warranty report ran for this recall.

On March 25, 2025, Forest River received a request from NHTSA to update the status of the remedy. Forest River has not been contacted by the manufacture GE stating that there is a remedy available. Updated notification dates.

On May 13, 2025, Forest River received a request from NHTSA to update the status of the remedy. Forest River has not been contacted by the manufacturer GE stating that there is a remedy available. Updated notification dates.

## Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. According to GE campaign 24E071: "Until a remedy is available, consumers should have the ICM870-16A-BH5400 "soft start" removed from their air conditioner(s). GE Appliances is still determining an appropriate remedy for the defect."

Identify How/When Recall Condition was Corrected in Production : The week of October 10, 2024, Forest River's Divisions were notified of the GE campaign to cease using the "soft start" on GE air conditioners.

### Recall Schedule :

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
