Please refer to BMW's September 25, 2024 Part 579 report assigned Foreign Recall ID 24F-220 by NHTSA.

Although initial information indicated that potentially affected vehicles for the US market were all contained, preliminary reviews suggested that a small number of potentially affected vehicles may have been released from the vehicle assembly plant.

In October, further reviews and analyses were conducted to determine which, if any, vehicles may have been potentially affected.

Vehicle assembly information and supplier production records were used to determine the specific dates of potentially affected vehicles.

As a result, BMW will be conducting a voluntary safety recall for these specific vehicles.

Description of Remedy:

Description of Remedy Program: The front passenger air bag will be replaced.

Owners will be notified by First Class mail advising them of the recall and to schedule an appointment with an authorized BMW dealer to have the remedy performed for free. Although unlikely, owners who have had this remedy performed at their own expense prior to the recall notification,
