Chronology :

On October 15, 2024, Forest River's Office of Corporate Compliance ("OCC") was notified by the manufacturing plant of a concern having to do with the mounting of the TF044E4MD-S - 3 In 1 Stove, as instructed by the stove manufacturers' installation instructions. OCC opened a research item.

On October 16, 2024, OCC contacted the vendor to ask about the mounting, and if the installation instructions were correct.

On October 17, 2024, OCC received a letter of installation variance for the manufacturing plant. OCC began trying to identify any further Forest River manufacturing plants that may use the stove.

On October 28, 2024, OCC contacted the vendor to inquire if any other Forest River manufacturing plants were using the stove.

On November 1, 2024, Forest Rivers Corporate Committee voted to recall.

On November 8, 2024, OCC discovered that Cedar Creeks installation is different in material use. Forest River is removing Cedar Creek from the recall.

On November 20, 2024, Forest River amended this recall to reflect the remedy.

On November 21, 2024, Forest River amended this recall to reflect there was not a warranty report run for this concern. It was brought to our attention from the manufacturing plant during a routine inspection.

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to install adequate securement to the stove.
