**Description of the Defect :** The Solar Charge Line, Front LED Hitch Light and the Pass-Thru Light, might be inconsistently wired to a 50AMP mini-breaker. The solar controller may have the incorrect gauge hardness wires.

**Description of the Safety Risk :** The wire(s) connected to the improper mini-breaker could potentially melt, causing a short which could potentially lead to a fire, property damage and/or personal injury.

## Chronology :

On October 30, 2024, During a routine Corporate Standards Inspection of the manufacturing plant it was discovered that certain 12V wiring may be inconstantly wired.

On October 31, 2024, OCC was informed by the Standards Manager of the concern, a research item was opened.

On November 4, 2024, OCC contacted the manufacturing plant to see if it is believed any vehicles left the facility in this condition.

On November 8, 2024, Forest River's Corporate Committee voted to recall.

On November 14, 2024, Forest River amended this recall after receiving NHTSA's acknowledgement letter requesting warranty data. There was not a warranty report ran for this concern.

**Description of Remedy :**

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to connect the wire to the proper mini breaker.
