On September 26, 2024 IMC received a dealer report of a hole present in a fuel tank. On October 10, 2024 IMC reviewed internal records and determined the vehicle had been previously altered during vehicle certification testing. Thereafter, additional review was conducted of units that had undergone the same certification testing, resulting in the identification of 4 total vehicles that were converted for sale in the US after undergoing certification testing. On October 24, 2024, IMC began an investigation. IMC has not identified any reports involving fire or injuries associated with the concern and has not identified any associated NDFR's. On November 7, 2024, IMC's Executive Review Committee decided that the altered fuel tank concern resulted in a safety-related defect.
