CW45/2022: First report about a potential issue with a non-U.S. part (TopView camera control unit). Analysis started.

CW45/2022 - CW04/2023: Analysis conducted. Indication that the U.S. part could also be affected.

CW05/2023: Delivery in the Volkswagen Chattanooga factory was stopped for vehicles built with the potentially affected TopView camera control unit. The potentially affected vehicles placed under stop order were repaired before delivery.

CW38/2024: Topic was presented to Volkswagen Pre Product Safety Committee due to claims in a foreign country (outside USA). Clarification requested for potentially affected markets. Identification of potentially affected vehicles re-initiated including the vehicles in the stop measure.

CW39-45/2024: Ongoing analysis of affected vehicles identified that a limited number of vehicles in the US market were delivered with the affected part prior to the stop order going into effect.

November 13, 2024: The Volkswagen Product Safety Committee determined a non-compliance recall for the affected vehicles.
