Description of the Noncompliance : According to the supplier: "The amber lense does not have the adequate reflective surface area to meet F/CMVSS 108."

Chronology :

On November 4, 2024, Forest River's Office of Corporate Compliance was notified that the amber turn signal lamp does not meet FMVSS 108 surface area reflectivity.

On November 5, 2024, OCC communicated with the manufacturing plant in order to ascertain if the lamps had been used in any Forest River product.

On December 2, 2024, OCC was told by the manufacturing plant that they had identified that the suspect lamp had been used, and which models' year vehicles were affected. As a result, OCC opened a research item.

On December 4, 2024, Forest Rivers Corporate Committee voted to recall.

On February 5, 2025, Forest River received information from the supplier stating that they are sending a single sample lens to Forest River's manufacturing plant for a physical test. Forest River reached out again to the supplier and the manufacturing plant on March 10, 2025, for an update. At this time, we do not have a schedule of when we will have remedy parts in our hands or available from Kaper II/Future Sales.

On March 28, 2025, Forest River received a request from NHTSA to update the remedy status. At this time, we do not have a schedule of when we will have remedy parts in our hands or available from Kaper II/Future Sales.
