The corrected control parameters in software were implemented in October of 2024 and all FSABs after this date have been produced with the new control parameters. Extended Chronology: 3rd of December 2024 Volvo cars received the first report from the supplier indicating issues with the Far Side Airbag. An investigation was initiated to review the customer symptom and a possible root cause.

11th of December the investigation was escalated via the Critical Concern Action Process (CCAP) to the Critical Concern Management Team (CCMT). The issue was concluded as potentially critical and CCMT initiated a technical investigation to conclude customer symptom, risk assessment, root cause etc.

On the 13th of December 2024 the technical investigation was completed, the CCMT team took the decision to start preparation for a recall as it was judged as an increased risk towards motor vehicle safety.

Description of Remedy:

Description of Remedy Program: To remedy concerned vehicles, Volvo Cars will replace the inner FSAB in

the driver front seat.
