Description of the Defect : Due to an error by a plant assembly worker, the second and/or third row seat mounting bolts may be missing.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : Seats with missing seat mounting bolts may not properly restrain an occupant during certain collisions, thereby increasing the risk of injury.

Description of the Cause : Missing seat mounting bolts due to plant assembly worker error.

Identification of Any Warning that can Occur : Seat rattle noise from and/or looseness of the seats.

Description of Remedy :

Description of Remedy Program : All owners of the subject vehicles will be notified by first class mail with instructions to bring their vehicles to a Kia dealer. Kia dealers will inspect and install any missing seat mounting bolts. As an additional precautionary measure, dealers will verify the seat mounting bolts on all seats are properly fastened. Kia will reimburse owners for repair expenses already incurred pursuant to Kia's General Reimbursement Plan filed May 1, 2024.

How Remedy Component Differs from Recalled Component : The seat mounting bolts are properly installed.

Identify How/When Recall Condition was Corrected in Production : Vehicles produced beginning on November 11, 2024 received an additional inspection procedure at the assembly plant to verify the seat mounting bolts were properly installed. 2025MY EV9 vehicles manufactured from 10/16/2024 through 11/10/2024 will be inspected and if necessary, repaired prior to distribution to dealers.
