

## IMPORTANT SAFETY RECALL

Tusk 2Track Adventure Rear Tire (150/70B-18; Part No. 2137740001)

May 10, 2024

To: Rocky Mountain ATV/MC, Inc. Dealers

This notice letter is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

**Description of defect or noncompliance and evaluation of the risk to motor vehicle safety**: Rocky Mountain ATV/MC, Inc. ("RMATV") has determined that on certain Tusk 2Track Adventure rear tires (150/70B-18; Part No. 2137740001). The tread knobs can experience chunking and potentially separate from the carcass over time. Due to a deviation in the manufacturing process, the tread of certain tires might not have been provided sufficient time to cure to the carcass during vulcanization. If a tire did not cure for sufficient time during the manufacturer's vulcanization process, over time it could lead to chunking of the tread knobs during use. In that event, the handling or steering characteristics of the motorcycle could be affected. This could increase the risk of a crash.

You are receiving this letter because RMATV's records indicate you may have received tires that are subject to this recall.

## HOW TO IDENTIFY IF YOU HAVE AN AFFECTED TIRE

Affected tires are those with the following Tire Identification Numbers (TIN):

- DOT 038 MFFTR2 4323
- DOT 038 MFFTR2 4423
- DOT 038 MFFTR2 4523
- DOT 038 MFFTR2 0124
- DOT 038 MFFTR2 0224

The TIN can be found on one sidewall of the tire as indicated by the arrow in the image.

**Remedy**: Consistent with RMATV's commitment to safety and customer satisfaction, RMATV will make available to all purchasers of the recalled Tusk 2Track Adventure rear tires, 150/70B-18, an identical size and model replacement tire at no charge, along with a \$100 per tire pre-paid debit card to cover installation and disposal costs associated with replacing the recalled tires. This remedy is currently available and the recall will continue for 18 months, ending November 30, 2025.

## Please immediately do the following:

- If you are still in possession of any of the recalled tires you must immediately cease all sales of those tires and return any remaining inventory to RMATV for destruction. This is required by federal law. Please contact RMATV at our recall customer service line at 800-966-1852, or email at recall@rockymountainatv.com for return and full reimbursement procedures. Please note that it is a violation of Federal law to sell or deliver a tire covered by this defect determination.
- 2. RMATV has worked with the National Highway Traffic Safety Administration ("NHTSA") to prepare formal notification of this recall to owners. The owner notification letter, as approved by NHTSA is enclosed herewith. Please immediately provide the owner notification letter to all customers to whom you have provided one or more of the recalled tires, or immediately provide RMATV with the customer contact information, using recall service line at 800-966-1852, by email at recall@rockymountainatv.com, or if you are not able to use one of those methods, by US mail at:
