Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2021-2023 Montana, 2021-2022 Montana High Country, 2022-2024 Fuzion, 2021 Cruiser, 2024 Aspen Trail LOFT Fifth Wheels and Travel Trailers. As a result, Keystone RV is conducting a safety recall.

Reason for this recall:

It has been decided that the vehicles in the recall population with the Suburban stove LED backlight printed circuit boards (PCB) are not fully coated. The lack of adequate coating in the connection passages between the layers of the PCB can allow liquid from the cooktop surface to accumulate which could result in a short circuit resulting in failure of the PCB. If the PCB fails, it can become overheated and the polyethylene cover of the lights can melt and possibly ignite causing a fire. The vehicles included in the recall are:
