This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Cruiser RV (Cruiser) has decided that a defect which relates to motor vehicle safety exists in certain 2023-2024 Avenir, Embrace, Shadow Cruiser, MPG, Radiance, Stryker, Twilight travel trailers and 2023-2024 Essence fifth wheels. We apologize for any inconvenience this action may cause you, however your safety and continued satisfaction are of the utmost importance to us.

***Reason for  
this recall***

Vehicles subject to this recall were built with a Suburban range / oven with LED lights behind the knobs. These LED were not properly protected by the manufacture and could overheat and malfunction. This malfunction could result in the LED lights melting and or catching fire, which could lead to property damage, personal injury or death.

Instructions for the repair and a list of the affected coaches with their VIN #'s can be found on the warranty portal.
