Fisker is initiating a Voluntary Safety Recall Campaign specifically addressing Outer Door Handles, set to commence on June 17, 2024. This recall encompasses all Model Year 2023 Fisker Ocean vehicles intended for the markets of the United States, Canada, and the European Union.

We kindly request that you diligently follow the instructions outlined in the attached bulletin number TSB55062401 to inspect your inventory for any vehicles affected by this safety recall. This proactive measure is crucial for ensuring the ongoing safety and satisfaction of our customers. By thoroughly inspecting each vehicle, we can promptly identify and address any issues, thereby maintaining the highest standards of quality and trust in our products. Your cooperation in this matter is greatly appreciated, as it helps us uphold our commitment to delivering safe and reliable vehicles.

After following the attached instructions, if any vehicle in your inventory is found to have a defective outer door handle, the defective handle must be replaced. This ensures that all vehicles meet safety and quality standards before they are made available to customers. It's essential to



thoroughly inspect each vehicle to identify any issues and address them promptly to maintain the integrity and reputation of your inventory. All affected vehicles that have been inspected according to the attached instructions with no defective door handles found may be shipped and sold to all markets.

A subsequent dealer notification letter will be issued once the remedy involving replacement parts (Outer Door Handles) becomes available to Fisker.
