**Effective immediately and until further notice, these MY 2023 and MY 2024 Fisker vehicles are on mandatory stop-sale hold.**

**DO NOT sell, or offer for sale or lease, any vehicle included in this hold.**

**STOP SALE INFORMATION**

Fisker is initiating a Voluntary Safety Recall Campaign to address a potential issue with the electric water pump in all Fisker Ocean vehicles. This recall will commence on June 25, 2024, and includes certain Model Year 2023 and Model Year 2024 Fisker Ocean vehicles destined for the markets in the United States, Canada, and the European Union. Only vehicles manufactured before March 17, 2024 will need the electric water pump replacement.

We kindly request your immediate attention to the instructions detailed in the attached bulletin number TSB30032401. It is imperative to replace the electric water pump in any affected vehicles within your inventory as part of this safety recall. This proactive step is essential to ensuring the continuous safety and satisfaction of our customers. By replacing the electric water pump in each vehicle, we aim to promptly resolve any potential safety issues, thereby maintaining the highest standards of quality and trust in our products. Your cooperation in this matter is greatly appreciated, as it reinforces our commitment to delivering safe and reliable vehicles. All affected vehicles that



have had the electric water pump replaced according to the attached instructions may be shipped and sold to all markets.

A follow-up dealer notification letter will be issued once the replacement parts (electric water pumps) are available from Fisker. Your diligence and support in this recall campaign are vital to our collective effort to uphold our standards and customer trust.

By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.
