**Customer Reactive Statement** 

There is a possibility that out-of-specification driver's side front axle upper left control arms may have been installed in Cayenne vehicles within a population identified through production records. The subject out-of-specification may break under heavy dynamic load. To address this issue, the subject control arms must be replaced prior vehicle delivery.

Do not deliver any affected vehicles prior to performing the remedy.

Please contact all affected customers who have already taken delivery.

The affected driver's side front axle upper left control arm must be replaced. The remedy parts are being prepared.

The affected driver's side front axle upper left control arm must be replaced. A remedy update will be provided as soon as possible.

The safety of our customers is of the utmost importance. Out of an abundance of caution, Porsche recently decided to conduct a voluntary recall after discovering that the driver's side front axle upper left control arm does not meet the required safety standards in a limited number of Cayenne models produced between May 9th and June 19th 2024. Within this range, most affected vehicles will be remedied prior to delivery, and only a small percentage of the total cars affected have already been delivered to customers, who will be notified in due course. The remedy will be free of charge, and no incidents as a result of this issue are known so far. Customers are advised to drive carefully until the remedy can be performed.
