Ref: NHTSA Incorrectly Located License Plate Light/FMVSS 108 24V-766

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

McNeilus has decided that certain 2010-2024 McNeilus Rear loaders fail to conform to Federal Motor Vehicle Safety Standard number 108, "Lamps, Reflective Devices, and Associated Equipment.". These vehicles were built between 6/25/2010- 6/5/2024.

- Your McNeilus vehicle is being recalled.

Why is a recall being conducted?

The license plate is illuminated from the bottom and does not comply with the requirement for the license plate illumination location in FMVSS 108.

What are we doing about the problem?

McNeilus has a new bracket that will allow the correct illumination of the license plate from the top.
