In the course of continuous product monitoring and internal tests, Automobili Lamborghini S.p.A. has determined that a defect that relates to motor vehicle safety exists in certain Revuelto model year 2024.

In the affected vehicles the screws on the oil circuit connection flange from radiator to the oil tank may not have been properly torqued.

Should the mounting assembly not meet the torque specification, the oil line could leak oil, which vapors could potentially contact hot components increasing the risk of a fire.

For the reasons listed above, Automobili Lamborghini decided to launch a safety recall campaign to rework the involved cars.

This campaign will be published in LIASS on January 10th, 2025.

In order to further support you in answering questions to your customers, we are attaching the FAQ (Frequently Asked Questions) form you must follow. Since these activities are extremely important, we are confident you will make every effort to ensure that the vehicles are repaired in the shortest time possible.

IMPORTANT REMINDER: VEHICLES AFFECTED BY SAFETY & COMPLIANCE RECALLS

New Vehicles in Dealer Inventory: It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Pre-Owned Vehicles in Dealer Inventory: Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.

Ensure all relevant dealership personnel are aware of this notice so they are able to address customer questions. Owners of affected cars will be notified in writing.
