IMPORTANT SAFETY RECALL NOTICE

Kenway Submersible Trailer Light - Right Side SKU 64361 / UPC 792363646310 Recall
Kenway Submersible Trailer Light – Left Side SKU 64362 / UPC 792363643627 Recall

Dear Valued Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Harbor Freight Tools (“Harbor Freight”) has decided that certain units of the: (i) Kenway Trailer Light Kit, item number 64275 / UPC 193175352965, (ii) Kenway Submersible Trailer Light - Right Side, item number 64361 / UPC 792363643610, and (iii) the Kenway Submersible Trailer Light - Left Side, item number 64362 / UPC 792363643627 (collectively referred to as the “Trailer Lights”) fail to conform to Federal Motor Vehicle Safety Standard No. 108, “Lamps, reflective devices, and assoc. equipment.” All affected Trailer Lights were produced between May 1, 2023, and December 17, 2023. Our records indicate that you may have purchased at least one affected product, depending on the serial number on your product, as described in section B below.

A. What is the condition?

Certain units of the Trailer Lights, manufactured during specific production dates, do not meet the minimum requirements under Federal Motor Vehicle Safety Standard (“FMVSS”) number 108. During manufacture, the manufacturer’s production machinery had deteriorated, causing inconsistency in manufacturing and resulting in reflectors for certain units not reflecting light as intended, potentially reducing their visibility to other drivers. This could present a crash hazard if used on a trailer on the road.



IMMEDIATELY STOP USING THE TRAILER LIGHTS AND FOLLOW THE INSTRUCTIONS BELOW TO DETERMINE IF YOU HAVE AN AFFECTED UNIT. Affected units were sold between June 1, 2023, and February 16, 2024. The Trailer Lights have the item number and serial number on the back of the product. If your unit has any of the below serial numbers, it is part of the recall and should not be used, even if it appears to be in good working order.

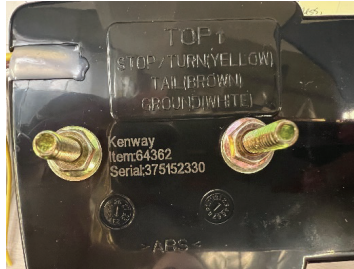
B. Affected Products

The item number and serial number can be identified by checking the back of the product.



Only certain units of the Trailer Lights are subject to this recall. Units with a serial number not on the chart provided above meet the requirements of the FMVSS 108 and are not included in the recall.

C. What will Harbor Freight do?

If you have an affected Trailer Light, Harbor Freight will provide a refund in the form of a Harbor Freight gift card or a replacement product (subject to availability of inventory) upon return of the product to your local Harbor Freight store.

D. What should you do?

Check the back of your unit and locate the item number and serial number. If your unit matches one of the item numbers and serial numbers listed in the above chart, you have an affected unit. Even if it appears to be working properly, please immediately stop using your Trailer Light and return the product to your local Harbor Freight store.

E. Reimbursement Information:
