Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2020–2023 GLE and GLS vehicles. **Our records indicate that your vehicle is included in the affected population.**

What is the issue?



The transmission control unit software might not meet current production specifications. The transmission may not fully downshift in certain conditions, and may cause the engine to stall. An engine stall increases the risk of a crash.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will update the transmission control unit software on your vehicle. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **30 minutes**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested. Additionally, please be aware that when the vehicle comes to a standstill, the engine can be restarted. The vehicle's steering and braking systems remain fully functional should this condition occur.

Steps to take.



- Find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2024030007**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already paid to have this recall repair completed, you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer. The following documentation must be presented to your dealer for reimbursement.

Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check, or copy of credit card receipt).
- Reimbursement will be made by check from your dealer.
