This is an important Safety Recall. The remedy will be performed <u>FREE</u> OF CHARGE to you.

Certain 2023 Porsche 911 Vehicles Porsche Recall ARA2 / NHTSA ID 24V-123

This notice is sent to you in accordance with the <u>National</u> <u>Traffic and Motor Vehicle Safety Act</u>. Porsche has decided that certain 2023 Porsche 911 vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 208.

What is the issue?

Porsche recently determined that in certain Porsche 911 vehicles, there is a possibility that the rear seat belt retractor locking mechanism used for child restraint installation might not operate as designed An improper y installed child restraint can increase the risk of injury in the event of a crash

What will Porsche do?

To remedy this issue, Porsche will check the rear three-point belts to ensure proper function and replace any rear seat belt

What should you do?

The remedy for this Recall is available now and can be carried out at your preferred Porsche Center. Please only install child restraints using the LATCH system until this recall is performed

Please contact any authorized Porsche Center to schedule an appointment to have this recall performed as soon as possible and to arrange for Porsche-provided alternate transportation, if necessary.
