This is an important Safety Recall. The remedy will be performed **FREE OF CHARGE** to you.

This notice applies to your vehicle:

Certain 2020 to 2024 Porsche 911 Vehicles
Porsche Recall ARA3 / NHTSA ID 24V-155

Dear

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect, which relates to motor vehicle safety, exists in certain 2020 to 2024 Porsche 911 vehicles.

What is the issue?

Porsche recently determined that in certain Porsche 911 vehicles it is possible that the front windshield and rear window were not bonded sufficiently to the body of the vehicle and may detach, increasing the risk of injury. During air bag deployment, an unsecured windshield may not support the front air bags as intended, increasing the risk of injury in a crash.

What will Porsche do?

To remedy this issue, Porsche will check the bonding around the front windshield and rear window and replace the windows and bonding, if necessary. This update will be performed FREE OF CHARGE to you. The update should take about half a day to complete, but, it may be necessary to make your vehicle available to your dealer for a longer period of time. Alternate transportation will be arranged, free of charge, if necessary.

What should you do?

The remedy for this Recall is available now and can be carried out at your preferred Porsche Center.

Please contact any authorized Porsche Center to schedule an appointment to have this recall performed as soon as possible and to arrange for Porsche-provided alternate transportation, if necessary.

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten days of receipt. If you have changed your address or sold the vehicle, please contact customer support so we can update our records.
