



## **IMPORTANT SAFETY RECALL**

### **SAFETY RECALL N871: Right Side Lower A-Pillar Bolt**

**Vehicles Affected: 2024MY Land Rover Discovery Sport**

**National Highway Traffic Safety Administration (NHTSA) Recall Number: 24V-163**

#### **Dear Land Rover Owner:**

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Land Rover has decided that a defect which relates to motor vehicle safety exists in certain 2024MY Discovery Sport vehicles.

Your vehicle is included in this Recall action.

#### **What is the reason for this program?**

On certain 2024 model year Land Rover Discovery Sport vehicles the right-side lower A-pillar bolt may be improperly fastened. For 7 seat specification vehicles this may result in reduced structural strength of the body structure.

A body structure with reduced structural strength may not adequately protect passengers in a crash, increasing the risk of injury.

#### **What are the warning signs of this condition?**

This will not be apparent to a customer during normal vehicle use.

#### **Are there any precautions that may be taken to minimize the safety risk until the corrective measures are implemented?**

Until such time as the recall is completed, customers are advised to be extra vigilant when operating the vehicle.

#### **What will Land Rover and your authorized Land Rover Retailer do?**

Affected vehicles will have the right-side lower A-pillar bolt inspected and tightened, as necessary. There will be no charge to the owners for this repair.

#### **What should you do?**

Please contact your preferred authorized Land Rover retailer and provide them with your Vehicle Identification Number (VIN) and request a service date to complete the work required under Program Code 'N871'.

**Attention Leasing Agencies:** If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within TEN (10) days.

### **How long will it take?**

The work will be carried out as quickly and efficiently as possible in order to minimize any inconvenience to customers and is expected to take approximately one (1) hour although your retailer may need your vehicle for a longer time. Your retailer can provide you with a better estimate of the overall time for the service visit.

If you have already paid for this concern before the date of this letter, Land Rover is offering a refund. To qualify for a refund, please provide your authorized Land Rover retailer with the original paid receipt.

To avoid delays, please do not send the receipt to Jaguar Land Rover North America, LLC.
