Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2024 E-Class 4MATIC vehicles. **Our records indicate that your vehicle is included in the affected population.**

### What is the issue?



The transmission wiring harness might contact the front drive shaft and chafe over time. This could damage the wiring harness, potentially resulting in a loss of vehicle propulsion without prior warning, which could increase the risk of a crash.

### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will check the transmission wiring harness routing on the potentially affected vehicles and rework it, if necessary. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **2 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

### Steps to take.

- Please mention you are scheduling an appointment for Mercedes-Benz recall **2024040007**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

**FOR CALIFORNIA ONLY:** A Proof of Correction certificate shall be issued to you by the dealer showing that the vehicle has been repaired under this Recall Campaign. This certificate may be required by the CA Department of Motor Vehicles for vehicle registration or operation.
