Dear Valued Fleetwood Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

REV Recreation Group Inc. has decided that a safety defect relating to motor vehicle safety exists on products within model year 2022-2024 Fleetwood brand Class A diesel motorhomes.

WHAT IS THE PROBLEM?

On certain Fleetwood Discovery 38 N model motor homes with a Remco 50-54 REBEL 4.0 GPM, larger capacity water pump, it was determined that a water pump harness was incorrectly designed at the battery control center causing the circuit not to be properly fuse protected.

Identify any warning which can precede or occur: The water pump may not work properly. A water pump harness that has been shorted or damaged may cause the wires to melt and smoke, posing the risk of a fire, that could result in property damage and/or personal injury.

WHAT SHOULD YOU DO?

Please make certain your motorhome is immediately inspected and repaired as necessary by contacting an **authorized REV Recreation Group servicing dealer**.

WHAT WILL REV RECREATION GROUP DO?

With your continued satisfaction in mind, it is our intention to have these repairs made at your convenience with as little disruption as possible. Effective immediately, REV RV dealers have been supplied with all the information needed to enable them to inspect and relocate the water pump circuit to a properly sized fuse as necessary.

The repair should take approximately 30 minutes (.5 hour) to complete; however, because of service scheduling times, your dealer may need the vehicle for a longer period of time. This service will be performed for you free of charge.

When you deliver your motorhome for repairs, your dealer will complete a **Repair Order**. Upon completion of the repair, please sign the **Repair Order** and fill out the enclosed self-addressed **Vehicle/Owner Information Update Card** and return it to REV Recreation Group.

If you have changed your address or sold the motorhome, please take a moment to provide the name and address of the person or dealership you sold it to on the enclosed **Vehicle/Owner Information Update Card** and return it to REV Recreation Group. This will allow us to update our records and if necessary, notify the new owner using the information you provide.
