



IMPORTANT SAFETY RECALL NOTICE

NHTSA Recall 24V-305

This notice applies to your vehicle, VIN _____

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Reading Truck Body LLC has decided that certain 2022-2024 RM-78 crane body trucks, fail to conform to Federal Motor Vehicle Safety Standard No. 108, "Lamps, Reflective Devices, and Associated Equipment." The RM-78 Crane body trucks that are a part of this recall were built from 07/06/2022 thru 04/19/2024, with the VIN(s) stated above.

What Is The Concern?

Reading Truck Body LLC has found that the tail light lamp exceeds the maximum height of 72" per the FMVSS 108 regulation. This may result in an increased risk of a crash.

What Should You Do?

The vehicle(s) listed were sold to you and have been identified as vehicle(s) that may be subject to this safety concern. Please confirm ownership of the vehicle(s), and make an appointment to have your vehicle(s) inspected and the tail lamps relocated at a Reading Body LLC authorized service location by calling 1-800-458-2226 (option 3). The inspection and repair will be completed at no cost to you.

How Long Will the Repair Take?

Please plan to leave your vehicle with the dealer for approximately 4 hours to allow time to complete the repair.

What if you have already paid for this repair?

You may be eligible to receive a reimbursement for the cost of repairs made prior to receiving this notice. Please enter a warranty claim on our website at <https://www.readingtruck.com/> as follows:

- Click on "Owners", then on "Warranty Information".
- Scroll down until you see "Submit a Warranty Claim".
- Complete all fields marked with a * and upload your receipts and photos of the fuse location.
- Click "Submit" and you will receive an e-mail with the claim number and information that you have submitted.

What To Do If You Feel You Received This Notice in Error?

If you are not the current owner of the vehicle(s) identified on the enclosed list, please call 1-800-458-2226 (option 3), or send an e-mail detailing the change of ownership to warranty@readingtruck.com . Please include the chassis VIN number, as well as any information you can produce on the vehicle's new owner [Name, Address, and Phone#].

Federal law requires that any vehicle lessor receiving this recall notice forward it to the vehicle lessee within ten days.
